NOTICE OF DEVELOPMENT REVIEW

This notice serves as an opportunity to comment on the application described below.


- Proposal:** The Columbia River Gorge Commission has received an application from Washington Oregon Wireless, LLC to install six antenna panels and three equipment cabinets at an existing communication facility, and to construct a six foot tall chain link fence to enclose the facility. These items have been installed and will be reviewed after the fact.
- Landowner:** Schreiner Farms, Inc.
- Location:** The subject property is located in the NW 1/4 of Section 9, Township 2 North, Range 13 East, W.M., Klickitat County, Washington (Klickitat County Assessor's ID 02130900000000).
- Case File:** C09-0012-K-G-21
- Zoning:** The subject parcel is designated Large-Scale Agriculture in the General Management Area and is approximately 640 acres in size.
- Comment Deadline:** The deadline for submitting public comment on the proposal is December 30, 2009.

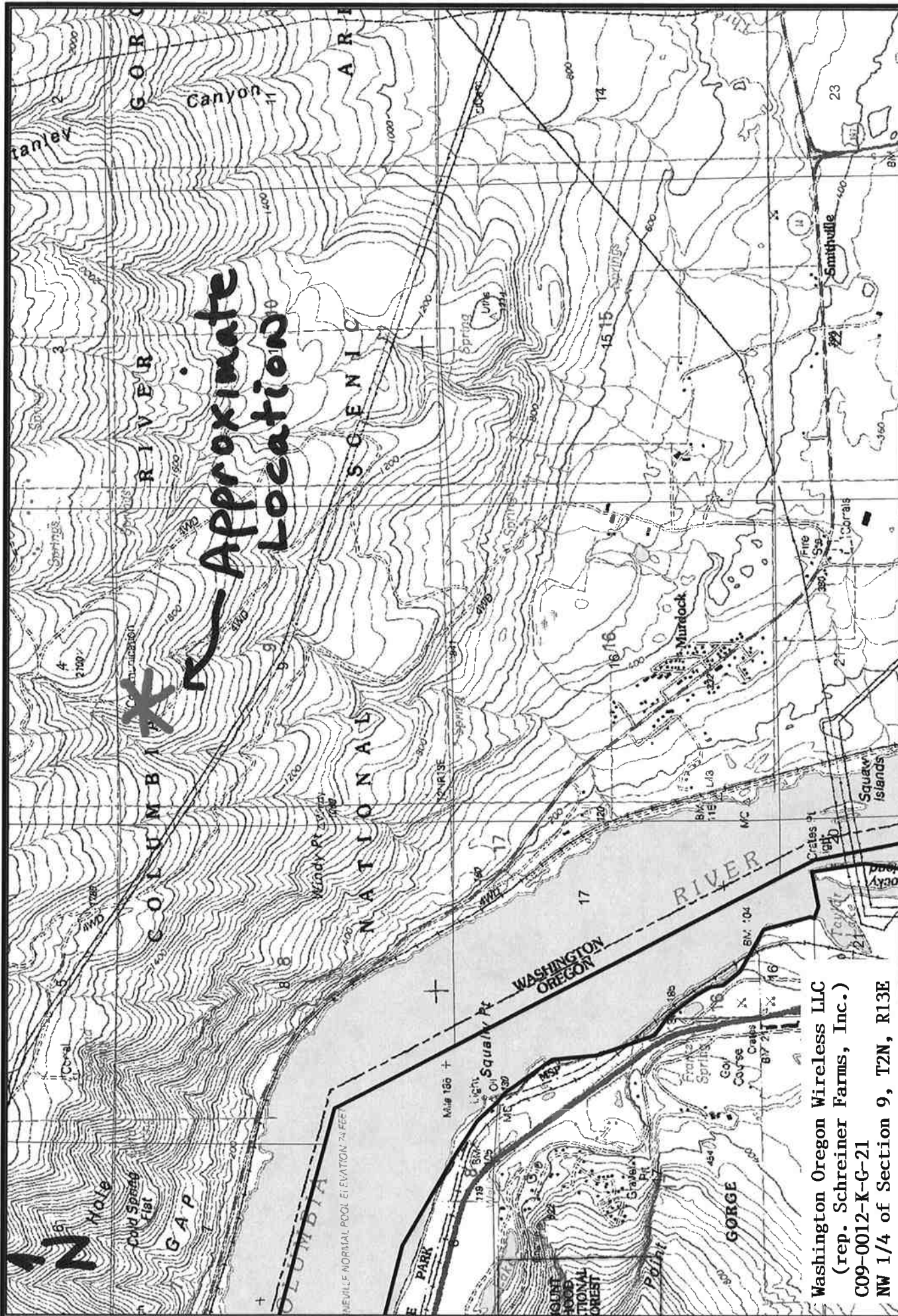

The Executive Director is scheduled to make a decision on the request by February 19, 2010.
