NOTICE OF DEVELOPMENT REVIEW

This notice serves as an opportunity to comment on the application described below.

- Proposal:** The Columbia River Gorge Commission has received an application from Robert and Barbara McCormick of McCormick Family Vineyards to: 1) construct a 10' by 32' by 10' deck and a 4' by 6' window on an existing winery building; 2) to convert approximately 600 square feet of storage space to tasting room use in the existing winery building; 3) to construct a 20' by 30' by 16' winery storage building; and 4) after the fact review of a concrete pad (to be the floor of the proposed building).
- Applicant Agent:** Craig Polzel of Craig's Construction
- Location:** The subject parcel is located west of Lyle-Snowden Road in the NE 1/4 of Section 28, Township 3 North, Range 12 East, W.M., Klickitat County, Washington.
- Case File:** C09-0017-K-G-19
- Zoning:** The subject parcel is designated Small-Scale Agriculture and is 109.55 acres.
- Comment Deadline:** The deadline for submitting public comment on the proposal is March 1, 2010.

Consistency with the National Scenic Area Act does not imply nor ensure compliance with all other applicable local, state, and federal laws.

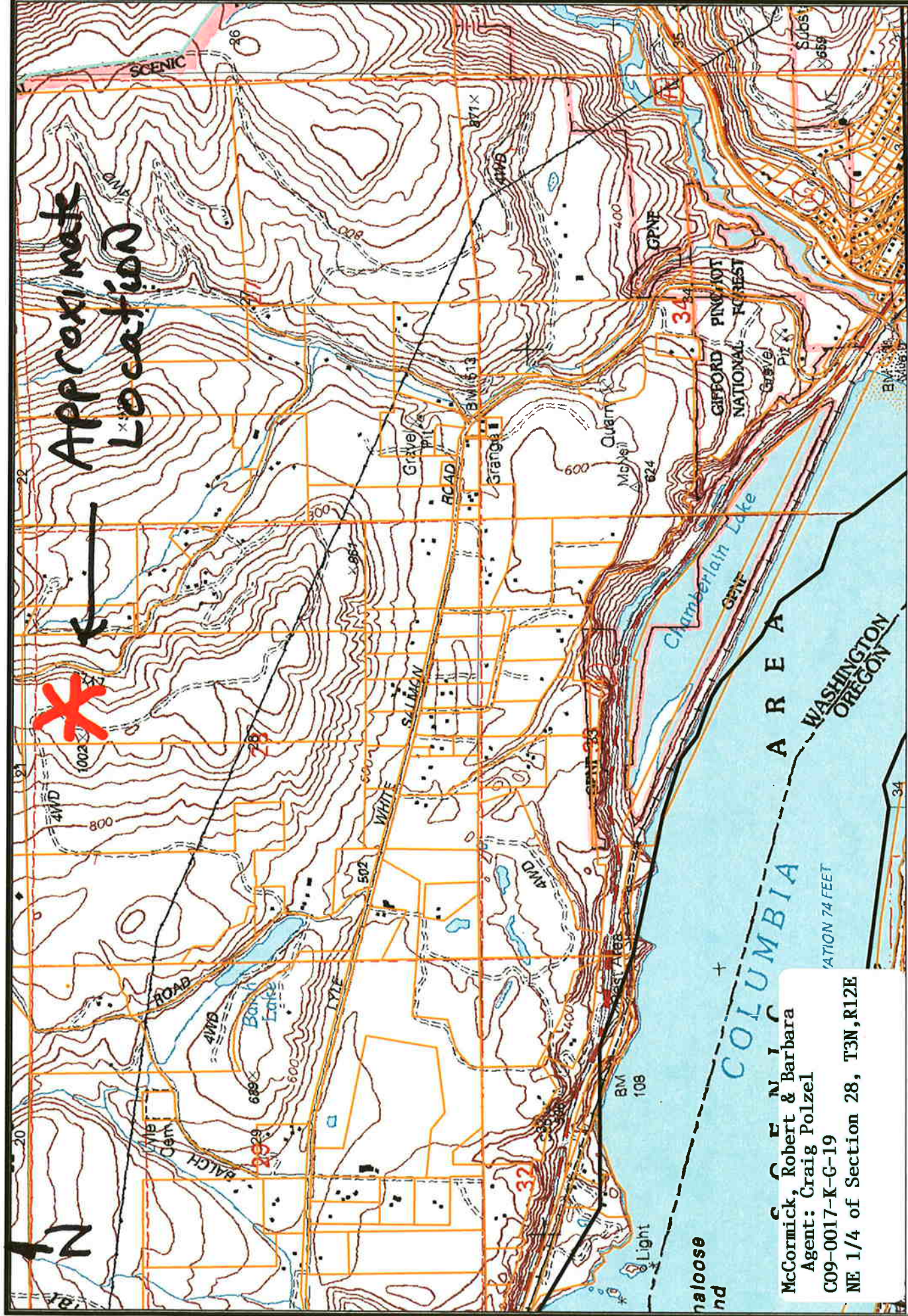
The Executive Director is scheduled to make a decision on the request by April 18, 2010.
