NOTICE OF DEVELOPMENT REVIEW

This notice serves as an opportunity to comment on the application described below.

Proposal: The Columbia River Gorge Commission has received an application from Charles Davis to construct a 1,875 sq.ft. single-family dwelling with an attached garage and driveway.

Location: The subject parcel is located in the NE 1/4 of Section 35, Township 3 North, Range 13 East, W.M., Klickitat County, Washington.

Zoning: The subject parcel is designated General Management Area Agriculture-Special and is 20 acres in size.

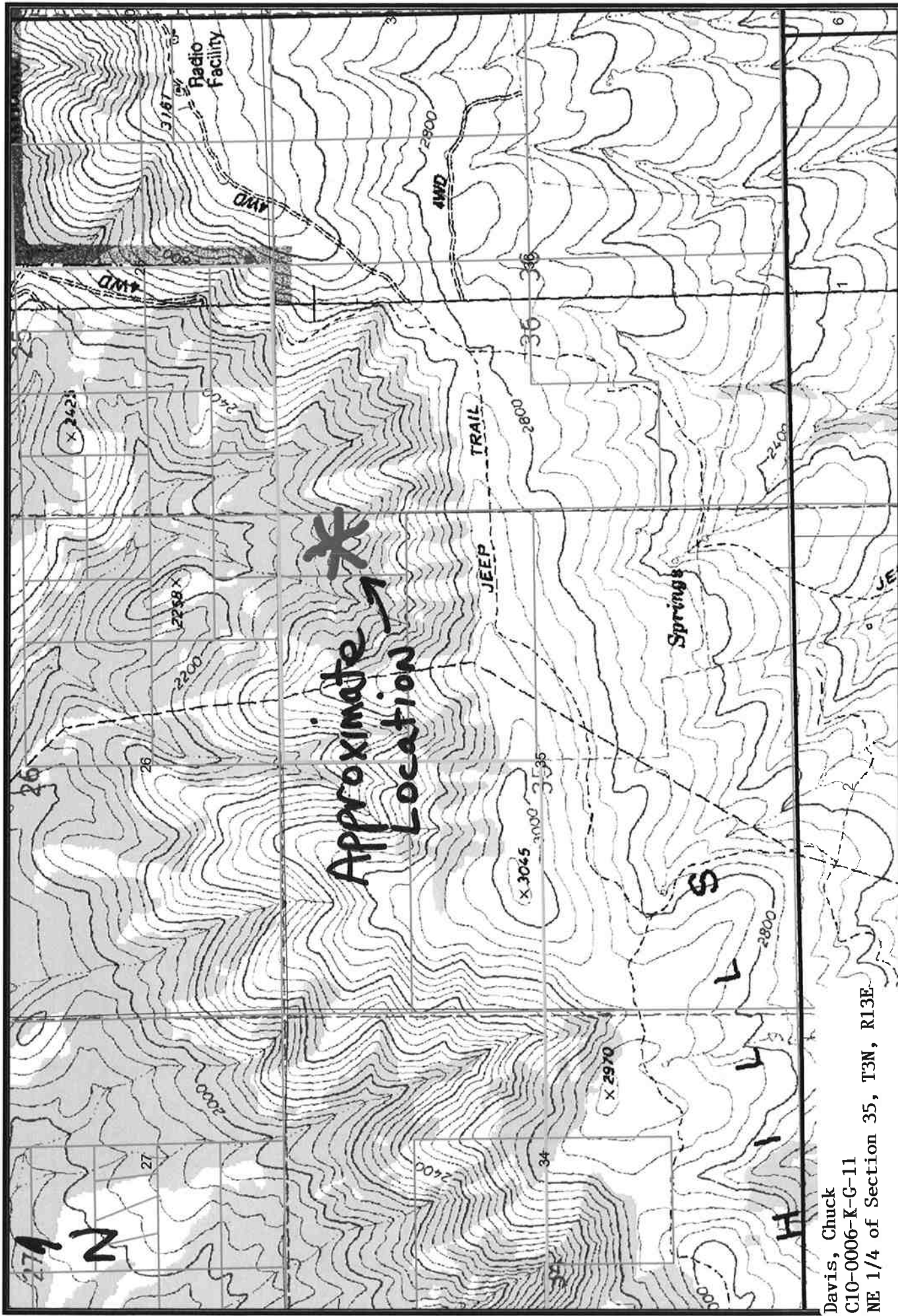

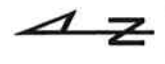
