NOTICE OF DEVELOPMENT REVIEW

This notice serves as an opportunity to comment on the application described below.


- Proposal:** The Columbia River Gorge Commission has received an application from John Richard and Rosemary Hoyt to construct a new 30' x 40' accessory building and place two shipping containers (one to be used for accessory storage and one to be used in conjunction with an agricultural use).
- Location:** The subject parcel is located south of County Road 1230 in the NE 1/4 of Section 33, Township 3 North, Range 12 East, W.M., Klickitat County, Washington.
- Case File:** C10-0009-K-G-11
- Zoning:** The subject parcel is designated Small-Scale Agriculture and is 13.17 acres in size.
- Comment Deadline:** The deadline for submitting public comment on the proposal is September 30, 2010.

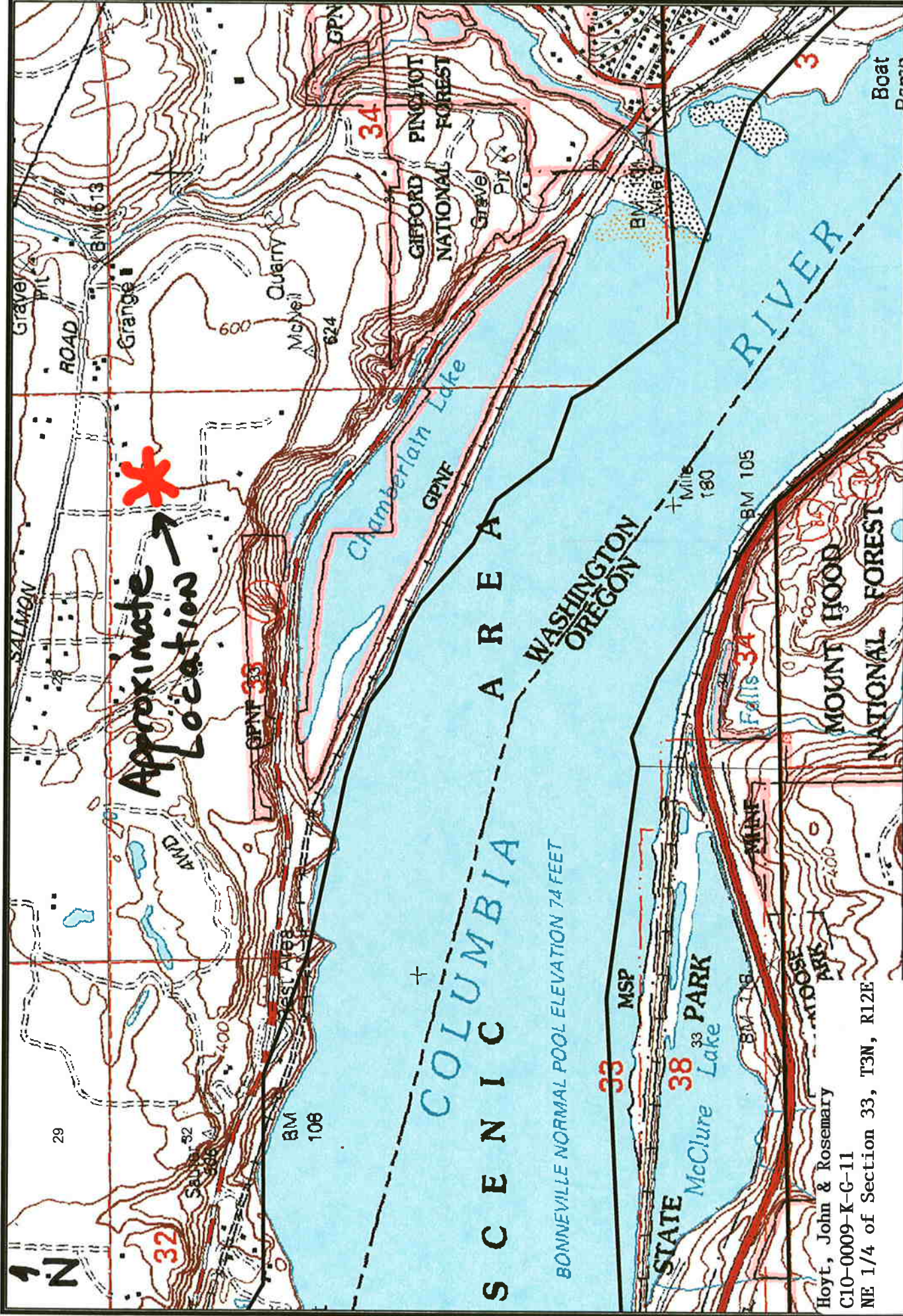

Consistency with the National Scenic Area Act does not imply nor ensure compliance with all other applicable local, state, and federal laws.

The Executive Director is scheduled to make a decision on the request by November 20, 2010.
