NOTICE OF DEVELOPMENT REVIEW

This notice serves as an opportunity to comment on the application described below.

- Proposal:** The Columbia River Gorge Commission has received an application from Peter and Therese Leon to replace an existing mobile home with a framed dwelling (footprint of 1,617 square feet) and to construct a detached garage (approximately 1,040 square feet).

- Location:** The subject property is located approximately 3 miles west of Wishram, north of Highway 14 in the NE 1/4 of Section 15, Township 2 North, Range 14 East, W.M., Klickitat County, Washington (Klickitat County Assessor's ID #0214150000200)

- Zoning:** The subject property is designated Large-Scale Agriculture and is 40.2 acres in size.
- Comment Deadline:** The deadline for submitting public comment on the proposal is October 19, 2011.

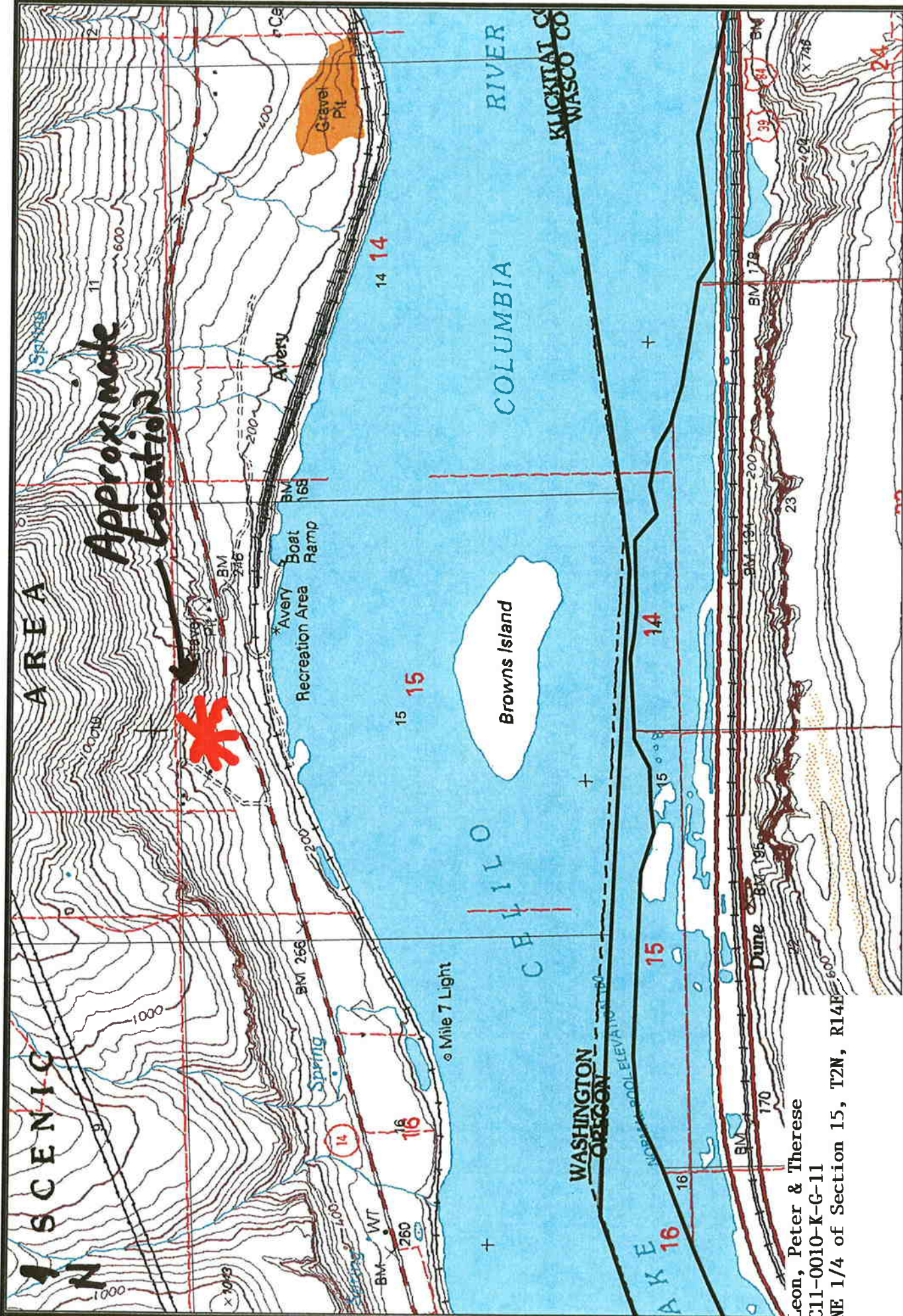
