This case involves an appeal by Friends of the Columbia Gorge, Inc. and Columbia Gorge Estates, LLC (collectively, “Appellants”) of a survey of the Dallesport Urban Area on property owned by Keith Arndt in his capacity as trustee of the Arndt Living Trust. Appellants challenged the survey. The Columbia River Gorge Commission met on January 14, 2014 to hear oral argument and deliberate to a decision. Prior to oral argument, the Commission encouraged the parties to consider settlement. As a result, the parties reached a proposed settlement, and reported back to the Commission that they had reached an agreement, but with the understanding that three of the parties needed to take further action to approve the settlement before the settlement could be final. The parties requested a 60-day stay to secure the final approvals, and the Commission granted the stay. Thereafter, the parties’ respective final decision makers approved the settlement. At the Commission’s meeting on February 11, 2014, the parties

moved the Commission to accept the settlement. The Commission voted to accept the settlement.

## **I. PARTIES**

## **II. PROCEDURAL MATTERS AND RULINGS**

### **Disclosure of Conflicts of Interest and Ex Parte Contacts**

Gorge Commissioner Bowen Blair disclosed that he was executive director of Friends of the Columbia Gorge, Inc. from 1982 to 1988. Subsequently, Commissioner Blair served as a board member of Friends of the Columbia Gorge, Inc. up to March 2011. Commissioner Blair stated that he believed he could be fair and objective in deciding this matter. No person raised any concerns or objections about this contact.

No other commissioner disclosed any conflict of interest or ex parte contact and no party or other person<sup>1</sup> raised concerns with any commissioner's participation.

### III. FACTS

The property that is the subject of this dispute is approximately 5.24 acres in size and is owned by Keith Arndt in his capacity as trustee of the Arndt Living Trust. The property is located within the Scenic Area. The northwest boundary of the Dallesport Urban Area traverses the property. Part of the property is in the General Management Area (“GMA”); part of it is in the urban area. The Commission discussed the historical facts of this matter through 2009 in its previous final order and opinion in a related appeal, No. COA-K-09-03.

After the Commission’s decision in 2009, all parties sought judicial review of the Commission’s decision. Klickitat County, Mr. Arndt, and the Gorge Commission entered into a settlement agreement and all parties dismissed all appeals. Mr. Arndt conducted a survey of the urban area boundary line on his property and submitted it to the Forest Service, which signed the survey document within a signature block that stated it was accepting the survey on behalf of the Gorge Commission. Subsequently, Klickitat County issued a final plat and a boundary line adjustment decision based on the survey.

In the instant appeal, Appellants challenge what they alleged was a decision of the Gorge Commission determining the location of the Dallesport Urban Area boundary line across Mr. Arndt’s property in Klickitat County.<sup>2</sup> In a related appeal, CRGC No. COA-K-13-01, Appellants challenged the final plat and boundary line adjustment decision. This Order does not involve that related appeal.



<sup>2</sup> One of the issues on appeal would have been whether this matter involved a decision of the Gorge Commission that could be appealed to the Gorge Commission. The Gorge Commission did not resolve this issue, and this Order takes no position on that issue.

#### IV. ORDER

The Commission accepts the settlement agreement between Friends of the Columbia Gorge, Inc., Columbia Gorge Estates, LLC, Keith Arndt and the Arndt Living Trust, and Klickitat County resolving CRGC appeal no. COA-K-11-02.<sup>3</sup> The Commission staff will include the Dallesport Urban Area boundary as shown in Exhibit A of the settlement agreement into the legal description for the Dallesport Urban Area. Lot 1 of SPL 2008-24 as amended by BLA 2012-04 is entirely within the General Management Area. Lot 2 is entirely within the Dallesport Urban Area.

This Order does not adopt that resolution and the Commission takes no position on the statements in the resolution.
