If you wish to speak to the Commission during the public comment period or to address one of the agenda items marked for public input, please follow the Zoom Webinar Protocol and Public Comment Guidance found on our website at: [May 12, 2020 Gorge Commission Meeting](#).

Be courteous and professional - Your message is best received if it has a neutral and professional tone. Address the issues and facts that are of interest to you, not personalities.

Effective use of public comment time - All speakers will be offered three (3) minutes to express their thoughts. The Chair may announce a change in a meeting’s time limits in order to keep the meeting on schedule.

Plan your speaking points in advance to help ensure a clear message for the Commission to hear. The points you are making will have the most impact if you can ensure their accuracy. Organize your thoughts in the following manner: your Point, Reasoning, an Example of your point, and Summary of your point. The Commission strives to use this P.R.E.S. model in its own discussions and will be listening for these parts of your message.

Please be respectful of your time so that others may also have an opportunity to speak.
