Yes.....for the most part I support the specific language input provided by Michael Lang.

With regard to the first staff person's presentation, I totally disagree with incorporating what's considered the "new/improved" term, scenery vs. scenic.

I would remind the Commission that this is the National Scenic Area, not the National Scenery Area. The principle aspect of the Act is that the visually important areas of the Gorge are protected for their scenic aspect present at the time of the Scenic Area enactment. The Commission's principle role is the protection of this aspect.

Please insure that the Commission is made aware of my comments/concerns prior to the closure of this meeting.
