Call to Order and Roll (10:04 AM)

Chair Blair called the meeting to order and Nancy Andring called roll.

Welcome from local officials (10:05 AM)

Martha Bennett, Chief Operating Officer for Metro welcomed the Commission. She spoke to the common goals and challenges that Metro and the Commission share and the relationship between the two agencies.

Approval of Minutes for February 14, 2017 Commission meetings (10:23 AM)

Commissioner Ericksen moved to adopt the February 14, 2017 meeting minutes with minor spelling and grammar corrections. Commissioner Nichols seconded the motion. The motion passed on a voice vote with Commissioner Liberty abstaining.

Opportunity for Treaty Tribe Nations to address Commission (10:25 AM)

As part of the Government to Government consultation process the Commission welcomes input from treaty tribe members on any issue on the agenda and any other matters.

Louie Pitt. Jr from Confederated Tribes of Warm Springs updated the Commission on various efforts related to rail safety and responsibility. Thanked Gorge Commission for hosting a meeting to discuss the issue. Treaty Rights education is important; the tribes gave 10 million acres to the United States – important to distinguish ownership from occupancy and sovereignty of economic uses off reservation lands. Affordable housing crisis experienced by all four treaty tribes and social programs are needed. Efforts to increase cooperation with federal agencies. Remember that plan review matters – how are we doing? Looking for ways to support us with legislators, budgets, and participation. Communication is critical.

Opportunity for Public Comment (10:41 AM)

The following provided public comment to the Commission on items not listed on the agenda:

Gorge 2020 Management Plan Listening Session Summary Report (11:05 AM)

Jessica Gist, Natural Resources and Land Use Planner, presented the comments received during the three public Listening Sessions and provided an update on other outreach methods. Krystyna Wolniakowski, Executive Director, summarized comments received during the City Council and County Commission meetings to date. (see attachment C1-2)
