This notice serves as an opportunity to comment on the application described below.


- Proposal:** The Columbia River Gorge Commission has received an application to construct a covered crush deck and an agricultural structure at the Cascade Cliffs Winery.

- Location:** The subject parcel is located south of and adjacent to Highway 14, about 3 miles east of Horsethief Lake State Park, in the NE 1/4 of Section 16, Township 2 North, Range 14 East, W.M., Klickitat County, Washington (Parcel No. 02141600000500).

- Zoning:** The 23.85-acre parcel is located in the General Management Area and is designated Large-Scale Agriculture.
